Purpose. Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

**2019-001 Internal Controls over Financial Reporting
Significant Deficiency**

- The Authority did not accurately report federal program expenditures. Program expenditures for the continuum of care program included cumulative, prior year expenditures in addition to current year expenditures.
- The Authority did not accurately report federal program expenditures. Program expenditures for the state modernization program included cumulative, prior year expenditures in addition to current year expenditures.
- The authority's depreciation schedules do not clearly reconcile to the general ledger

Response

The Authority will prepare a schedule of Federal Awards for the fiscal year and continue to tie the drawdowns from LOCCS and/or IDIS to the General Ledger. The new Yardi Software has the capability to download reports into Excel, which should expedite the reconciliation between the GL and the FDS. In addition, the Authority will review the federal receipts and expenditures prior to submission.

The Authority will review the depreciation calculations to insure that the schedules are reconciled to both the FDS and GL. LHAND will also look into utilizing the fixed asset module of our new software to track our capital assets and calculate depreciation that will directly tie into the GL and subsequently to the FDS.

Material Weakness/Material Noncompliance

Condition

In our sample of Housing Choice Voucher tenant files, we identified the following:

- Nine instances of untimely reexaminations
- Six instances of missing third party verifications of income, assets, or deductions
- Two instances of third party verifications not agreeing to the amounts used to calculate the tenant's annual income
- Two instances of using an incorrect payment standard
- One instance of the release and consent form not being signed by two household members over the age of 18

LHAND has and/ or will be implementing the following Corrective Actions to address findings identified:

Beginning in September 2018, LHAND contracted with an outside consulting company to evaluate the Rental Assistance Department

Staff movement began in February 2019 and is ongoing as part of implementation of recommendations provided by the above mentioned review

In July 2019 contracting began with an outside firm to complete re-exams as part of the solution to address the need for timely re-exams

Implementation of new Federal software system occurred in June of 2019, we are encouraged that with proper training the new system will allow for quicker processing

Rental Assistance coordinates with the Compliance Department to coordinate staff training as needed, staff training is ongoing as topics are identified

Internal policies include that each tenant file should have an Occupancy Checklist

The Compliance Department conducts periodic file reviews

Progress Report.

Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan.

The LHAND will continue to maintain its units to HQS and State Sanitary code standards. The LHAND continues to work to ensure the federal public housing developments are maintained in decent and sanitary conditions. The LHAND was designated as a Standard Performer.

All goals relating to Section 8 Rental Assistance (#5, 6 and 7) are being met and/or progressing forward. The LHAND expects to maintain compliance with all SEMAP indicators. The LHAND has a monitoring component to evaluate case rep and inspector performance. The quality of housing under lease remains at a “B” rating overall.

Currently, there are 8 homeowners using HCV assistance at this time. The LHAND has used Project Based Assistance to increase utilization rates that has been very successful in expanding opportunities.

Progress was made on all goals relating to Planning & Development initiatives (#’s 4, 5, 6, & 8). P & D staff still participate with management staff in looking for alternative funding sources for the revitalization of Curwin Circle. P & D staff developed and implemented a citywide housing strategy included in the city’s 5-Year Consolidated Plan and Annual Action Plan for Housing that focuses on Lynn’s inner-city neighborhoods, public and assisted housing tenants and the homeless. The agency continued offering a number of housing grant and loan programs, including a Lead Abatement Grant, in LHAND’s targeted neighborhoods where the majority of LHAND’s assisted housing tenants reside.

As lead agency for the city’s “continuum of care” partnership, LHAND will conduct its annual “one night census count” and Gaps Analysis that captures the specific needs of the Lynn’s homeless. This year’s count will take place on 1/30/2019. The Lynn Continuum of Care also participates in an Unaccompanied Homeless youth Count in May of every year, sponsored by the Massachusetts Department of Housing and Community Development. This information serves as the basis for LHAND to apply for a number of successful Supportive Housing Program grants providing both housing and supportive services to Lynn’s neediest citizens. In addition, the information collected will be used to formulate an Action Plan with long term goals of ending chronic homelessness. The Lynn Continuum of Care has very active sub-committees working to end homelessness among the elderly, youth, and veteran populations.

Regarding Homeownership activities to date, 36 public housing families and 78 Section 8 participants, for a total of 113 have bought homes through the agency’s FSS Program. In addition, over 2488 families have participated in LHAND’s CHAPA certified First Time Homebuyer Class. Also, in 2019 14 First Time Homebuyer Loans were approved and disbursed totaling \$87,082.00.

LHAND still made available Set Aside Vouchers for Displaced by City, LHAND or Non-Profit; Voluntarily Relocate from Overcrowding; Displaced due to Dwelling Fire; Independent Living Center of the N.S. and Cape Ann; Andrew St. Site Based Supportive Housing Project; 33 High St. Veterans Housing; Site Based Normandy Permanent Housing Program for homeless and disabled families.

Planning & Development, in conjunction with Public Housing Management staff, identified and secured additional funding for the agency’s resident initiative programs.

LHAND implemented the Jobs Plus Initiative in January 2019, a program available to “work-able” residents of Curwin Circle aged 18 – 61. The program encourages the increase in earnings and advancement of employment of its participants with support related to work readiness, job placement, educational attainment, and financial literacy. To date 180 eligible residents of Curwin Circle have enrolled in the program, working with a case manager, utilizing resources through an on-site representative from the local Workforce Investment Board (WIB), attending on-site job fairs, reducing barriers related to employment, and benefitting from the Jobs Plus Earned Income Disregard with the goal of achieving economic self-sufficiency.

LHAND has met its goal of maximizing the amount of revenue received from state, federal, and local sources. Although LHAND has indeed maximized its available revenue, actual revenue from these sources is still uncertain. The federal operating subsidy is expected to be funded at an amount greater than in the past. However, the actual pro-ration factor is not known. The 2020 Capital Fund is expected to be funded at the same level as 2019. It is expected that funding for the HCV program will be increased slightly. However, it is unclear at this time at what per cent age HAP and administrative fees will be funded. State funding levels expected to increase but have not as yet been finalized.

The LHAND has continued to increase its revenue sources from entrepreneurial accounts. These endeavors have enabled the authority to maintain local police patrols and youth activities at the family development as well as supplant the lost operating revenues for both federal developments.
