The **Lynn** Housing Authority and Neighborhood Development, the Awarding Authority, invites sealed bids from Contractors for the **Window and Selective Door Replacement at Four 705 Family Developments** for the **Lynn** Housing Authority and Neighborhood Development in **Lynn**, Massachusetts, in accordance with the documents prepared by **Raymond T. Guertin, Architect.**

The Project consists of: **Window and Selective Exterior Door Replacement of 168 windows, 14 exterior entry doors, and 11 new screen doors at 6 separate buildings in four 705 family housing developments. Related work includes asbestos abatement, carpentry and painting.**

The work is estimated to cost **\$230,300.00**

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.

General bidders must be certified by the Division of Capital Asset Management and Maintenance (DCAMM) in the category of **General Building Construction.**

General Bids will be received until **2:00 p.m., Wednesday, February 6, 2019** and publicly opened, forthwith.

This project is being Electronically Bid (E-Bid). All bids shall be prepared and submitted online at www.Projectdog.com and received no later than the date & time specified above. General bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount (considering all alternates), and made payable to the **Lynn** Housing Authority and Neighborhood Development.

Deposits must be a certified or cashier's check, or money order. This deposit will be refunded for up to two sets for general bidders and for one set for sub-bidders upon return of the sets in good condition within ten (10) days of receipt of general bids. Otherwise the deposit shall be the property of the Awarding Authority.

General bidders must agree to contract with minority and women business enterprises as certified by the Supplier Diversity Office (SDO), formerly known as SOMWBA.
